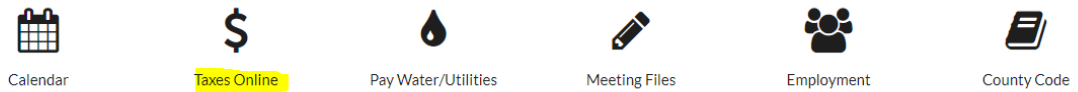
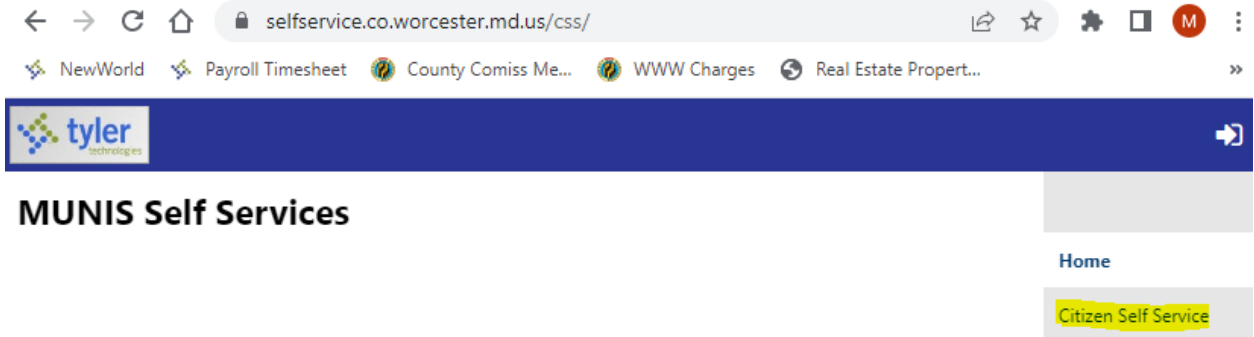


## How to Pay Taxes Online:

- 1.) Go to the Worcester County homepage at [www.co.worcester.md.us](http://www.co.worcester.md.us)
- 2.) Click on the Taxes Online ICON in the middle of the homepage

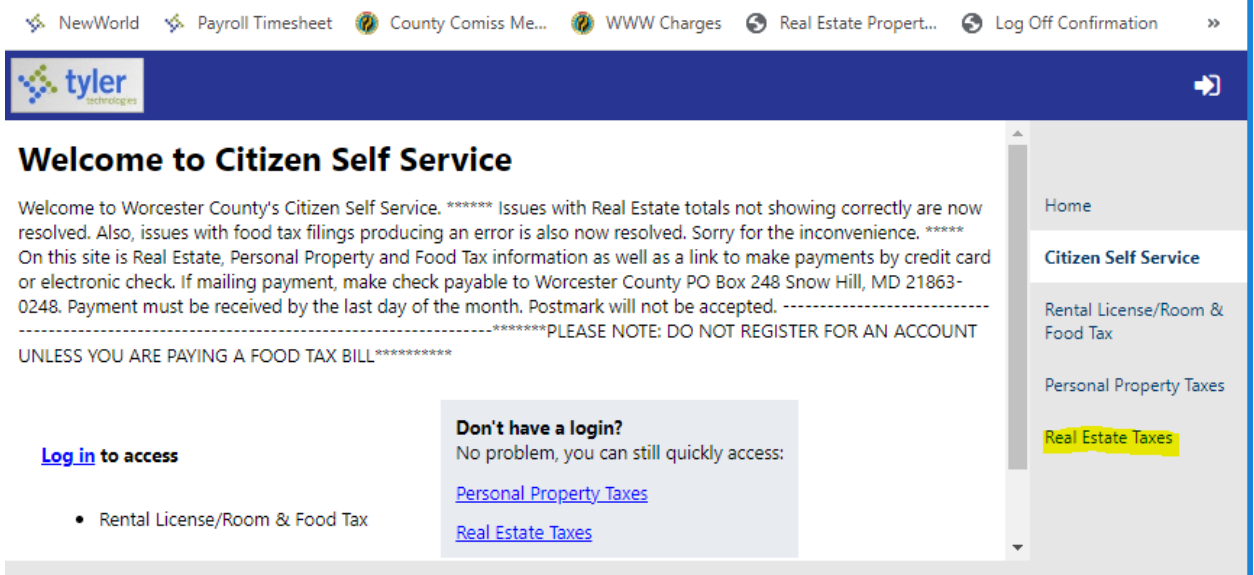


- 3.) Click on **Citizen Self Service** link on the right side of the webpage



- 4.) Click below **Citizen Self Service** link on the right side of the webpage and choose **Real Estate Taxes**:

- a. **Real Estate Taxes** - Real property includes land plus the buildings and fixtures permanently attached to it. Real property taxes are assessed on **residential homes and land** agricultural, commercial, industrial, and utility property.



- 5.) To Search for Real Estate Taxes:

You may access the Real Property Account by completing, **ONE** of the three search fields:

Search by **Parcel ID** use the eight-digit PROPERTY ID on your tax bill. Do **not** include the dash in your Parcel ID. For Example, if the property id on your bill is 01-999999, then enter "01999999".

**OR**

Search by **owner name**. Use last name then first name but a partial name is allowed.

**OR**

Search by Property **Address** (house number and street name). Street number is **not** required. Do **not** enter street name suffixes (Avenue, Street, Lane, etc).

**Real Estate Taxes**

To access an account, USE ONLY ONE of the three search fields. If searching by Parcel ID, use the eight digit PROPERTY ID on your tax bill. If searching by owner name, use last name then first name but a partial name is allowed. If searching by address do not include street type (Road, Blvd, Ave, etc.). Street number is not required. Four bill years are displayed after search, please click All Bills to display older years. If your account is blocked, please call 410-632-0686 x3.
